How to Become an FFA Member

^{*}Vet Med Practicum is designed for students who wish to pursue a career in the veterinary medical field. Students must complete Veterinary Medical Applications as a prerequisite, and must work or shadow at a veterinary clinic during enrollment of the Vet Med Practicum course. At the completion of senior year, students will be eligible to take the exam to earn their Certified Veterinary Assistant certificate through the TVMA. Please see Mrs. Hinojosa for more details.

***Plant Practicum is designed for students interested in the horticultural sciences. These students will spend their time in the greenhouse taking care of plants and conducting various research projects. Students must have successfully completed the other courses in the Plant Science Pathway to be eligible for this course. Please see Mr. Keys for more details.

Students are encouraged to work with their school counselor and the ag teachers to develop a course timeline that best suits their needs.

→ IMPORTANT ←

In order for a student to be an ACTIVE FFA member, they must be enrolled in an agriculture class for that year. This includes participation in contests, shows, and officer positions.

^{**}Welding Practicum is designed for students who hold an agriculture mechanics related job. Students must have successfully completed the previous courses in the ag mechanics pathway to be eligible for this course. Please see Mr. Hinojosa for more details.

Eligibility Policy

The Granbury Independent School District, by state law, must adhere to the "No-Pass, No-Play" policy of the Texas Education Agency. This policy states that all students participating in extracurricular activities must be passing ALL courses. Students who fail any subject for the six weeks will be ineligible for a period of three (3) weeks. Students may not participate in competition (livestock shows are included) during the three week period following the failing grade, but they are allowed to continue to practice and be part of other activities. At the end of the three weeks, a grade check will be done in order to determine if the ineligible student is passing. If the student is passing after the third week then the student becomes eligible for participation in competition after the fourth week (there is a one week grace period). If the student is still failing at the end of the three weeks, then the student will remain ineligible until the end of the next three weeks or the next grading period.

- It is important to note that the semester grade has no bearing on eligibility.
- One other important thing to note is that a grade of "<u>incomplete</u>" renders a student <u>ineligible</u> until it is changed to a passing grade. Students must clear incomplete grades before the end of the five (5) school days grace period following the end of the six weeks, or they are ineligible for the reminder of the following six weeks.
- Students are encouraged to notify their ag teacher as soon as possible if they suspect that a grade is below an acceptable level. It is sometimes possible to offer suggestions and /or locate appropriate tutors from within the Ag program. Remember, the ag teachers cannot help once grades are posted.

Granbury FFA Communication Policy 2021-2022

The following communication policy is designed to keep each agriculture student safe. Signing the "FFA Membership/SAE Contract" will signify that you acknowledge and agree with this policy and that you will not break the policy. If a student breaks this policy, the student could be subject to discipline or removal from the Ag program.

Granbury FFA Policies:

- Students may contact the Ag teachers during the hours of 7AM-9PM via email or remind.
 - Parent/guardians can contact the ag teachers via the Ag office phone between the hours of 8 AM-4:30 PM
- The student is NOT ALLOWED to contact the ag teachers via the ag teachers personal cell phone numbers in any situation.
 - Students cannot communicate one on one with the ag teachers through social media, text message, etc. (excluding school provided email). The student must include their parent/guardian in EACH conversation initiated through those venues.
- All animal emergencies between the hours of 9PM and 7AM, are the responsibility of the owner. If you need professional advice, please **contact a veterinarian.**
- GHS Ag Teachers are available via GISD email at all hours. If the ag teacher does not respond, speak to them at school the following day.
- Parents/guardians of the student are welcome to contact the ag teachers independently **during the** scheduled contact hours of 7AM-9PM.
- Under no circumstances should students request to follow school personnel on social media sites. It is not appropriate for a student, parent, or guardian to contact a teacher via social media.

However, Granbury ISD is not required to haul animals to shows not listed above, nor are they responsible for animals contracting disease at a show, especially if they are advised not to attend by advisors.

Parents/students must stay in contact with advisors as of the needs to weigh, oversee or transport animals for the sanctioned shows. Help us to continue to be here for the kids and to help each other with a positive influence. We ask that students keep the Remind notifications on at all times. It is imperative that we have constant contact with each of you.

Official Dress as outlined by the National FFA Association is as follows:

Boys

- White Button Down Shirt (with fold down collar)
- Black Slacks (jeans are not official dress)
- Black Shoes (black boots are allowed as per state Constitution)
- Black Socks
- Official FFA Tie (or plain black or navy tie)
- Official FFA Jacket

Girls

- White Button Down Shirt (with fold down collar)
- Black Skirt (school dress code will be followed for length)
- Solid Black Shoes (closed toe & closed heel)
- Black Nylons or Tights
- Official FFA Scarf
- Official FFA Jacket
- *NOTE: girls will be allowed to wear black slacks for certain events. Confirm with advisor before wearing

Proper Use of the FFA Jacket

These are some of the National FFA Guidelines for using & wearing the FFA jacket:

- Jacket is to be worn by members only
- The jacket should be kept neat and clean
- The jacket should be worn to official functions with the zipper fastened to the top, collar turned down, and cuffs fastened
- School letters and insignia of other organizations (i.e. all of the great buttons and stickers they give you in the career fair) should <u>not</u> be attached or worn on the jacket
- FFA members should act professionally while wearing the FFA jacket
- Only three medals should be worn on the jacket, these should represent 1) the highest degree attained, 2) the highest honor achieved, and 3) current officer pin.

*By signing the Chapter Handbook Acceptance Form, I have read this document and fully understand that I am expected to wear full official dress to all official functions, while traveling, and attending official FFA functions. I will also abide by the proper use of the FFA jacket as listed above and set forth by the National FFA Organization.

- f. No alcohol, tobacco, drugs or weapons (knives of any type) are allowed at any FFA activity or on any GISD property.
- g. Any project validated under another organization will be ineligible for exhibition under Granbury FFA. Exceptions to this rule will be: ex. when a student moves into the district and is in good standing with the previous organization and the FFA organization.

Initials h. The communication with ag teachers policy outlined in the handbook will be followed with NO EXCEPTIONS

- 2. Upon successful completion of a disciplinary placement to an alternative campus (BTC), if applicable and eligible you may be able to resume participation in FFA activities.
- 3. The Ag-Teachers reserve the right to remove any animals from the GHS Ag-facility for noncompliance of rules, neglect of care, rule violations, or violation of FFA Code of ethics, the Ag- Teachers also reserve the right to quarantine animals to remain locked in their pens or moved off farm for a specified period of time.
 - **a.** It is the responsibility of the animal owner to feed, water, clean, and care for the animal, this will be done daily according to the feeding schedule recommended by the GHS Ag teachers. (Don't do any changes without consulting the Ag Teacher)
 - **b.** Animals will be fed by the owners only, unless permission is granted from the animal owner.

Initials

- Pen and alley in front of pen will be cleaned daily as instructed by Ag-Teachers. If a pen goes without being cleaned longer than 3 days student is subject to an offense.
- d. Notify Ag-teachers if an animal becomes ill.
- e. Supplies for cleaning pen and grooming animals are the responsibility of the student.
- f. FFA animal projects at the Ag-Barn will be supervised exclusively by the GHS Ag-Science teachers.
- g. Pens will be assigned/determined by teachers and use only those assigned. You are responsible for leaving the pen clean and GISD property returned as it was checked out to you (Storage box, feeder, feed barrels, etc.) The proceeds from the sale of your animal will be held until the above items have been accounted for and your pen cleaned. This is all to be completed prior to the Annual Spring Cleanup meeting. You will not be allowed into the Ag center the next year if you fail to comply.
- h. Animals will be shown only by Granbury FFA Members and fitted according to rules of the show and/or approval of GHS Ag-teachers.
- i. Students must be enrolled in at least one ag-science class during the first semester to be eligible for use of the ag-facility or shop area for project exhibition.
- j. Only students with animals and their parents are allowed at the ag center (no friends, or persons giving rides allowed, they must remain in vehicle in parking lot)
- k. No animals will be purchased or unloaded without prior approval and supervision from the GHS Ag- teachers.

- Only market or prospect breeding animals that are to be shown during the current school year will be allowed. (No pet lambs, hogs, horses, etc.) No sows, cows, bred gilts, does, ewes, or animals retained for breeding purposes are allowed. Dogs are not allowed at the ag barn.
- m. Only Granbury FFA and Jr FFA members are allowed to house animals at the Ag-Center, pen will be delegated to FFA members first, then if available to the Jr FFA members on a first come first served basis.
- n. Doors and all pen gates will be kept shut at all times. Do not prop open doors.
- o. Space is limited-you <u>WILL</u> have to share space. Therefore, it is recommended that feed is stored in provided storage space and supplies locked in provided locker, and only small amounts of hay should be brought to store in sealed container.
- p. Hogs are very susceptible to disease; therefore bringing in hogs from outside (not purchased by one of the Ag-teachers) or unknown (sale barns) or unapproved sources will not be allowed to enter the GHS-School Farm area.
- q. Vehicles will not be driven off the concrete or gravel roads, proper driving habits will be followed at all times, both on the farm and on the road leading to the Agricultural Science Center. Failure to comply will result in driving privileges being revoked on the GHS campus. (Behind the Ag Center is not an established road)
- r. Water and electricity conservation is to be practiced at all times, no displays or non-essential equipment allowed, water may be turned off during times of mechanical failure or weather, plan accordingly.

s. All animals will be removed within one week of the show in which that animal has been properly entered. In the case of any animal not meeting this deadline, it will be sold at a livestock auction of the ag-teachers choice and funds will be retained by the Granbury FFA.

- t. Students must check out with an ag teacher before vacating the barn to ensure areas have been cleaned properly. Failure to clean area or check out with an ag teacher will result in the inability to return the following year AND holding of show monies until complete.
- No medications or feed additives are to be administered to animals without approval from the GHS Ag teacher. (There is a strict drug
 use policy for all livestock shows.)
- 4. By housing your animal at the Ag Center your animal may be used for laboratory activities during Agriculture Classes.
- 5. Show Animal Fees: \$30/animal at Ag Center \$ 5.00 for each additional animal, all SAE fees are due on date requested in the yearly calendar
- Removal from Ag Center and or FFA program will make animal or project ineligible to show. Also, removal will prohibit student from re-entering the Ag Center, Ag Classrooms or Ag Shop or participate in any FFA activity.
- 7. Students removed from Ag Program or FFA must reapply for membership the following school year. The student must interview with the Ag Teachers and their respective Principal. Re-admittance will be based on the panel decision.

I have read, understand, and will abide by all of the above rules. It is the discretion of the GHS Ag Teachers to have an animal(s) removed for rule violations. I agree that if the GHS Ag- teacher and/or the GHS administration deem necessary I will: upon notice from Granbury High School and the Agriculture Education instructors remove my animal(s) immediately, thoroughly clean and sanitize the pen or pens that I have used, return any equipment, and any other property of Granbury Independent School District, and repair any damage that occurred to my pen or pens during my use. If my animal is not removed within 48 hours of notice of eviction then the animal(s) may be removed and sold by the GHS Ag-teachers and all monies received be forfeited to the GHS FFA activity fund.

Three offenses of any of these rules will subject the student to eviction proceedings and loss of ability to show animals or projects or participate in any FFA activities. Major offenses will result in immediate eviction and loss of FFA membership.
